The N. C. State Board of Election ruled Thursday to count as valid the votes cast for all three candidates in last Tuesday's Primary for auditor. With the decision the board rejected an attorney general's opinion arguing that because J.E.B. Davis was ineligible to run, the votes cast for him should be invalidated. If the board had backed that opinion, Renfrow would have had a majority of the valid votes cast and thus be the outright winner. It now looks as if there will be a runoff between Edward Renfrow and William Chestnut.

N. C. Supporters of the Equal Rights Amendment believe the recent primary results have tipped the balance of the N. C. General Assembly in favor of ratifying the amendment.
