VA QUESTIONS

 \mathbf{Q} . I plan to take a correspondance course. The cost of the course far exceeds the benefits I am entitled to under the GI Bill. Can I obtain a Veterans. Administration education loan to pay the extra costs of the course?

A. No. Veterans pursuing a program of correspondence are not eligible for education loans to defray costs of these course.

Q. What is the minimum disability rating a veteran must have in order to be eligible to receive Veterans Administration vocational rehabilitation assistance?

A. A veteran must have a service connected disability of at least 10 percent for basis eligibility.

Q. Is a veteran receiving service connected disability compensation benefits at the 20 percent rate entitled to additional benefits for a spouse and children?

A. No. Increased benefits are only authorized if the veteran is rated 30 percent or more disabled.

O. If a veteran has received the previously authorized \$3,000 automobile grant is he now entitled to receive the additional \$800 increase in benefits now authorized?

A. No. The automobile grant payment is a one-time authorization and there are no provisions to pay the difference in the rates as the basic benefit is increased.
