**N. C. ARTS COUNCIL
AWARDS \$1.3 MILLION**

The N. C. Arts Council has just awarded \$1.3 million in grants supporting arts activities in 92 counties. The announcement comes jointly from Gov. James B. Hunt, Jr. and Sara W. Hodgkins, secretary of the N. C. Department of Cultural Resources. Awards were recommended at the spring meeting of the Council's board of directors. A total of \$3,320 was awarded to organizations in Polk County. Grassroots funds of \$1,070 went to the Polk County Community Arts Center and \$250 to The Upstairs in Tryon; and \$2,000 to the Polk County Community Arts Council for program expansion and continuation.
