Weather Friday: high 94, low 69; Saturday: high 92, low 69; Sunday: high 93, low 68; Monday: high 91, low 68. Tuesday morning had a cool breeze, but everyone would be delighted to have a good rain.

The temperatures reached 101 in New York's Central park Monday as the nation's monthlong heat wave continued its spread into the Northeast. The death toll from the hot weather since June 22 rose to at least 1,181 in 21 states.

The population in 19 western North Carolina mountain counties has increased by nearly 14 percent over the past 10 years according to a survey of the preliminary 1980 U.S. Census Bureau figures. In Polk County the figure showed only at 6.4 percent increase -- from 11,735 to 12,484. Columbus was down 3 percent from 731 to 709; Saluda up. 8.6 percent from 546 to 593; Tryon down 12.3 percent from 1,951 to 1,711. Tryon Town Manager Chuck Lott stated that the Town would have to contest the count as Tryon had more housing than it had 10 years ago. He stated that the census showed 100 vacant houses in Tryon and
