CREDIT GUIDE

To compare costs for credit, look for the "ARP", or annual percentage rate, advises Dr. Justine Rozier, extension family resource management specialist, North Carolina State University.

Federal law requires that all

credit contracts include the term "Annual Percentage Rate" in large print, and that this number be filled in on the contract before you sign it.

The annual percentage rate might be as low as 12 or as high as 36 percent.

DYING WITHOUT A WILL

There is no legal requirement that everyone have a will. The laws of North Carolina provide who your heirs will be and how your property is to be divided among them if there is no will. You might say that the state makes a will for you.

For example, if a person dies without a will, leaving a spouse and children, the surviving spouse would take everything if the estate is no more than \$15,000.00. If it is more, the children would share in the estate.

Another example would be a single person who dies without a will, survived by both parents and a sister. In this case, the parents would inherit all the property, and the sister would receive nothing.

Of course, a will could change these results, according to the desires of the person making the will.

North Carolina public libraries have free pamphlets on the subject of wills, published by The Lawyers of North Carolina.
