## Sentenced In Murder Trial

John Edward Ward, 23, of Arcadia, S. C. entered a plea of guilty Tuesday in the Polk County Superior Court to being an accessory after the fact in the September 1979 slaving of James Delmar Gosnell, 22, in his Columbus residence.

Judge Edwin S. Preston, Jr. sentenced Ward to serve 5 to 7 years.

In August, Gosnell's wife, Carolyn Lee Gosnell, 28, was convicted of second degree murder of her husband and was sentenced to 25 years. The state contended that Ward, Mrs. helped brother. Gosnell's transport Gosnell's body, dead from shotgun wounds to a well near Arcadia, S. C.
