\$2.7 Million In Farm Product Sales For Polk County. Census Bureau Reports

The market value agricultural products sold by the 194 farms in Polk County amounted to \$2.7 million for 1978 or an average of \$13,816 each, up from \$2.2 million in 1974 with an accompanying increase in production costs, according to a preliminary report of the 1978 Census of Agriculture released today by the Bureau of the Census, U. S. Department of Commerce.

A breakdown of the county's total agricultural sales for 1978 followed by that for 1974, is as \$613,000 Crops, follows: \$541,000; with compared livestock and livestock products, \$1 million and \$838,000; poultry and poultry products, \$1 million and \$727,000.

While the value of gross sales rose, the farmers' cost also climbed since 1974. Expenditures Henderson County courthouse in for feed for livestock and poultry Hendersonville. A number of for 1978 were \$1.1 million compared to \$704,000; costs for gasoline, diesel and other petroleum products were \$91,000 compared to \$78,000. Farm energy costs of all types totaled \$129,000 for 1978. The estimated market value of machinery and equipment per farm increased from \$10,944 to \$16,817.
