The Polk County District Court was held Oct. 29th with the Hon. Judge Loto Greenlee presiding. The results were as follows:

Wm. Frederick Austin, Jr. — called and failed to appear on charge of driving 70 in 55 mile zone — prayer for judgment continued for the called and failed charge.

Milton Boyd — communicating threats — continued to Nov. 19th.

Charles Kimuel Davis, Jr. — trespass — 30 days, suspended one year, pay \$50 fine and costs, not go on premises of Mr. Byars nor his place of employment named Buffey without written permission of Mr. Byars.

Charles F. Fears — Driving with license revoked: reckless driving — continued to Nov. 19th.

Charles Alan Gary — intoxicated and disruptive — 30 days, suspended 6 months, pay cost and \$50 fine.

Ronnie Gary — trespass — continued to Nov. 19th.

Ronnie Gary — communicating threats — continued to Nov. 19th.

David Holm — trespass — not less than 60 days nor more than 90 days, suspended for 2 years, pay \$50 fine and cost of court, not molest or harrass prosecuting witness or go on her premises without written permission.

rape — probable cause hearing.

Michael David McGuinn — injure personal property — State takes voluntary dismissal upon payment of cost and restitution of \$102 to prosecuting witness.

Raymond Mills — contribute to delinquency of minor — state takes voluntary dismissal upon payment of cost, not to go around, to bother or harrass juvenile, obey all instructions about juvenile from her guardian.

Nathaniel Oliver Suber — felonious breaking and entering and larceny — continued to Nov. 19th.

Kenneth Paul Thompson — simple possession of marijuana — continued to Nov. 19th.

Chris Tucker — contribute to delinquency of minor — State takes voluntary dismissal upon payment of cost. Defendant not to be around, harrass, molest or talk to juvenile without written permission of parents of juvenile.

Mayalo Vences — Possession of stolen property — State takes voluntary dismissal.

Mayalo Vences — felonious possession of marijuana — negotiated plea of guilty to simple possession of marijuana — pay \$25 fine and cost of court.  
Johnny Womack — trespass —

State takes voluntary dismissal.

Johnny Womack — assault on female — not less than 6 months, suspended for 2 years, pay \$100 fine and cost of court; not assault, harrass, molest or interfere with prosecuting witness not go on premises of place of employment of prosecuting witness without her written permission.

Austin Pace — reckless driving, reckless driving and resisting arrest, reckless driving, reckless driving — continued to Nov. 5th.

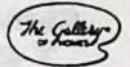
