Encouraged by support from President-elect Ronald Reagan, Sen. Bob Dole said Thursday he and other senators will push for quick passage of a \$39.8 billion tax cut when Congress reconvenes next week. The Kansas Republican will become chairman of the Finance Committee in January

The nation's banks Thursday raised their prime lending rates by one full percentage point to 15.5% in the biggest one-day increase in more than a year
