


Plugged Shotguns No Longer Required For Small **Game Hunting**

RALEIGH - Hunters do not need to use plugged shotguns for hunting small game this year, according to enforcement officials of the N. C. Wildlife Resources Commission. In the past, small game hunters could only use shotguns capable of holding a maximum of three shells in the magazine and chamber when hunting quail, squirrel, grouse and rabbit. This provision was eliminated under the 1980 game law, and hunters may now use the maximum number of shells the shotgun will hold when hunting these species. However, shotguns must still be plugged when hunting migratory

"Hunters are required to use plugged shotguns limiting them to a maximum of three shots when hunting migratory birds which includes all waterfowl, doves, woodcock and snipe," said Gene Abernethy, chief of the Commission's Division of Enforcement. "These birds are protected under the federal

NOTICE OF TAX LISTING

Notice is hereby given that:

1. Real personal property is to be assessed for ad valorem taxation as of January 1, 1981.

2. Listing will begin on January 2, 1981, and will end on January 31, 1981.

3. Beginning late in December 1980, the tax office will mail to each person whose property was assessed for taxation for 1980 a form for listing real and personal property. This form must be returned to the Tax Supervisor's Office on or before January 31, 1981, except as provided below.

4. Taxpayers who do not wish to list their property by mail may list in person in the Tax Supervisor's Office, Polk County Courthouse, Columbus, N. C. between 8:30 A.M. and 5:00 P.M. Monday through Friday. Bring your listing form with you when you come to the tax office to list.

5. All persons who on January 1, 1981, own property subject to taxation must list such property either in person or by mail during the listing period stated in Item 2 above. Failure to do so will subject such persons to the penalties prescribed by law.

6. To be eligible for property tax relief for the elderly and permanently disabled, the application must be completed and filed with the tax office by April 15, 1981. This application is in Section A of your listing form. Be sure to answer all questions on the application.

NOTE: If you have not paid your 1980 property tax, you have until 5:00 p.m., January 5, 1981, to pay them without interest being added. After January 5, 1981, 2% interest will be added with an additional 34 of 1% being added each month thereafter until paid.
