## Howard J. Spika Resignation Final

President Howard J. Spika of St. Luke's Hospital will resign July 1 this year, according to Chairman O. O. Paulsell, who read Mr. Spika's letter of resignation at last week's meeting of the Governing Board.

Mr. Paulsell pointed out that Mr. Spika had been persuaded to stay on two more years after he wished to resign in 1979.

"There are no words to express how much Howard Spika has done for St. Luke's Hospital during the 15 years he has served it". Mr. Paulsell said. "He's entitled to his retirement. We'll just have to move on from here."
