Two men with stockings over their head entered Tryon Pharmacy and a man with a gun went back to where Ellis Fincher, owner was working and told him not to move. Mrs. Linda H. Fincher saw the man with the gun and went out the door screaming. When this happened the two men left and made their getaway in a black pick-up truck.

A Ford pick-up truck was located a short time later on Rock Cut Road in South Carolina. It was reported as having been stolen in Lyman, S. C.

Mr. Fincher said that the Tryon Police where at the store within minutes of the robbery.
