OF ANNEXATION

The public will take notice that the Board of Commissioners of the Town of Tryon will hold Public Hearings at Town Hall at 7.00 P.M. on each day beginning Monday, the 18th day of May 1981 and continuing through and including Friday, the 22nd day of May 1981 on the question of annexation of the territory described below, pursuant to Part 2, Article 4A, Chapter 160A of the General Statutes of North Carolina, at which time plans for extending municipal services to said territory will be explained and all persons resident or owning property in said territory and all residents of the Town of Tryon will be given an opportunity to be heard.

The report of plans for extending services to said territory and a detailed map showing said territory under consideration is available for public inspection at Town Hall.

The areas to be considered for annexation are described as follows:

- 1. Town limits south to state line.
- 2. Gillette Woods area to include East Park Drive. Dogwood Trail areas and Sunny Slopes Subdivision.
- 3. Hogback Mountain Road to Thermal View Heights areas,
 - 4. Country Club Heights area.
- 5. Town limits north to Pacolet River to include Harmon Field and Tryon High School areas to Lynn bridge.
- 6. Lynn to Wilderness Road area, and
- 7. New Market Road to state line and Ridge Road.
