Labor analysts say President Reagan's decision to fire all 12,000 striking air traffic controllers and deny them amnesty is the toughest action ever taken by a U. S. President against striking federal employees.

Spartanburg attorney Clyde H. Hamilton will be nominated by President Reagan to be a U. S. Federal District Judge for the South Carolina District. Hamilton, upon confirmation by the Senate would succeed Judge Robert F. Chapman of Camden, who recently was appointed judge on the Fourth Circuit Court of Appeals.
