Legal! Legal! Legal!

The Polk County Department of Social Services Board has received a letter from the State of North Carolina Attorney General's Office that the employment of William A. McFarland as attorney for the Social Services board was legal and that his services should be viewed as valid and binding.

Commissioner Opal Sauve had claimed that Mr. McFarland had served illegally.

Henry H. Burgwyn, Assistant Attorney General stated in his letter that as the law is now interpreted, if the board of county commissioners assert their statutory and contractual duties (rather than designate them) the County Commissioners have the power to appoint the attorney and the Board of Social Services has the right to give their approval.

William A. McFarland had been serving as the attorney, but the County Commissioners terminated his services and appointed Wm. H. Miller to succeed him. The Social Service Board took the position that Mr. McFarland had been doing a good job and should have been contacted about the position and given the opportunity to accept or reject the position. The County Commissioner then stated that McFarland had been serving as attorney illegally.
