Man Murdered On Trade Street

Steve Faggart of Tryon was killed at 9:53 a.m. Tuesday while at work on the Faggart Building on North Trade Street here. Held for his murder is Alvin Edney Whiteside, also of Tryon.

Tuesday morning, Tryon Police Chief Jerry Ross said that an autopsy had not been held and it had not been determined how many bullets had entered Faggart's body. Witnesses stated that he had been shot at close range by a hand gun.

Chief Ross said that the cause of the shooting was not known at this time, but that the investigation was continuing.

Dr. Charles Blomeley and Dr. Fred Wier, Polk County Medical Examiner examined the body at the site.
