President Reagan declared Thursday that he has "no plans to send American combat troops into action" in El Salvador or anywhere else, but refused to flatly rule out that possibility in the future.

At least three NASCAR drivers allegedly used their race cars to transport narcotics in a "masive drug operation" involving 70 people, FBI agents said Thursday, Robert Pence, head of the FBI's North Carolina office. said 66 of the 70 were indicted by a federal grandjury in Miami and four were included in Charlotte, ending a 21/2 year investigation into narcotics activity in South Florida and North Carolina.

Still Destroyed

Using dynamite police destroyed the nine-50 gallon barrels and confiscated four cases of illegal liquor. - from Spartanburg Herald

The appeal was heard Nov. 19th, 1981 by the Court of Appeals and the judgment was given Jan. 25, 1982 by Judge Earl W. Vaughn with Judges Webb and Hill concuring.

Paving Firm Is Fined

A Rutherfordton paving company has been fined \$175,00 and its president sentenced to 30 days in federal prison in connection with the bid rigging of a 1977 highway contract.

Thompson Contractors, Inc. and its president, Lawrence Thompson, were sentenced Tuesday in federal court in Raleigh, after pleading guilty to violating the U. S. Sherman Antitrust Act.

The Pleas were part of a plea bargain with the U.S. Justice Department.

The charges involved bids on an 11.8 mile resurfacing project in Henderson and Polk Counties. The company was awarded a \$320,131.24 contract for the project in 1977 and completed the resurfacing in May 1978.

The indictments charged the firm and unidentified coconspirators with discussing prospective bids and submitting intentionally high bids, as well as bids that contained false, fraudulent statements and entries. Asheville Citizen
