Two Valedictorians

The Spartanburg County School District I Board of Trustees decided Tuesday night that Landrum High School would have two valedictorians this year.

The decision was made to settle a controversy sparked by the district's lack of clear policy on what constitutes senior status for a student. The question arose when a student who will complete graduation requirements at Landrum High this spring in three years achieved a higher class average than a student who will complete graduation requirements in four years.

A salutatorian remains to be chosen.

In other matters, trustees voted unanimously to rehire all teachers in the district to the extent that funds are available.

Trustees adopted a \$300,000 bond resolution for the renovation of Chapman High School.

Supt. H. E. Hipp reported that a visiting committee from the Southern Association of Schools and Colleges will be in the five elementary schools in District I next week as part of the district's required two-year self-evaluation. — Spartanburg Herald

A Campobello man was arrested Wednesday night after he allegedly shot his mother-in-law, according to detective Dennis Sprouse of the Spartanburg County Sheriff's Department.

Jack Earl Foster, 35, of Route 1, was charged with assault and battery with intent to kill, Sprouse said.

Sprouse said Foster was reportedly driving a van belonging to Leona M. Cash of the same address. Cash went to get her van, got into it to drive off. A shot was fired through the windshield, spraying pellets and glass into her face, the detective said.

Cash was not transported to the hospital. — Spartanburg Herald
