Weather Friday: high 64, low 28, hum. 50%; Saturday: high 50, low 27, hum. 52%; Sunday: high 55, low 27, hum. 45%. Monday was another beautiful day.

At least 25 people died in the capital of the Azerbaijan republic after ethnic rioting broke out, but dozens more people were killed or wounded as the unrest spread across the republic. Extra internal security troops were flown to the area by the Soviet Union to try to quell the violence. Most Armenians are Christians; most Azerbaijanis are Shiite Moslems.

Coretta Scott King delivered her annual "state of the dream" address at Ebenezer Baptist Church, where her husband was pastor, before about 1,000 people. She called on President Bush to help unify America.

Missing Woman Found Friday

Alma Lee, 25, was found Friday about 3 p.m. about 1/4 mile from Twin Lanes Rest Home from where she disappeared Tuesday morning. Other than being tired, cold and hungry, she appeared to have survived the ordeal except for frost bite, and many scratches, according to Jim Cochran, Polk County Emergency Management Coordinator.

Ms. Lee was found at the residence of Mr. and Mrs. Graham Newman. Mrs. Newman, who knew people were searching for Lee, called the Tryon Police about 2:30 p.m. Friday when she saw a woman try to enter her house through a back screen door. Within a few minutes searchers arrived at the house. They could not find Ms. Lee and were about ready to leave when they decided to search a separate storage room again and this time they found her. She had gone back into the storage room after the rescuers had already searched it.
