Mikhail S. Gorbachev told the Community Party on Monday it must give up its unchallenged right to rule the Soviet Union to the tide of democratic reform he let loose five years ago.

U.S. District Judge Harold Greene on Monday ordered former President Reagan to give a videotaped deposition for the Iran-Contra trial of John Poindexter and to turn over 33 entries from his diary immediately to his former national security adviser. Reagan promptly invoked executive privilege to avoid turning over portions of his diaries.

Former state Insurance Commissioner John Ingram, who unsuccessfully challenged Republican Jesse Helms in 1978, filed Monday to run again for the Democratic nomination for U.S. Senate.

Senate tax writers spared no rhetoric Monday in criticizing the use of surplus Social Security taxes to hide the size of the federal deficit, but they and their expert witnesses disagreed on what to do about it.

Bill McKaig Files For School Board

Bill McKaig of 203 Capps Rd. Tryon has filed his candidacy for Polk County Board of Education.

He is a 1950 graduate of Tryon High school and College of the Desert, 29 Palms, Calif., and Chaffey College, Alta Loma, Calif. He earned an A.A. degree in Business Administration.

He served from 1950 to 1971 in the U.S. Air Force reaching the rank of Chief Master Sergeant (E-9). During this time he served in Korean and Vietnam Wars. He received numerous decorations and commendations including the Bronze Star in Vietnam and the Meritorious Service Medal upon his retirement from Travis A.F. Base. His last assignment was superintendent of the largest field maintenance unit in the Air Force which is responsible for all heavy maintenance designed and transit aircraft.

For the last eleven years he has been employed as a shift supervisor at Barnett Southern.

He and his wife, Dorothy have been married 38 years. They have 3 children. Two are adopted. Bryon who is a senior at Western Carolina; Nancy who is employed at White Oak and plans to continue her training in nursing. Their own child, Pamela is a Junior at Tryon High.

Joan Nash Files For Commissioner

Joan L. Nash of Laurel Ridge Road in Columbus Township has filed as a Republican candidate for the office of Polk County Commissioner.

Since 1980, Mrs. Nash has been Community Schools Director for the Polk County Schools. She edits "Polk Sallet," a tabloid publication mailed to all county residents, directs a volunteer program, and coordinates programs for students and adults involving the extended use of school facilities.

A native of Illinois, Mrs. Nash graduated with honors from Beloit College in Wisconsin in 1972, along with her oldest daughter. She was a graduate student at the University of Iowa for five years, where she earned an M.A. degree in 1973 and taught French for three years. She was admitted to the University of Iowa College of Law in 1976, but married John Nash and moved with him to Polk County in 1978. She is the daughter of the late Dr. Jules Le Grand, who moved here the same year.

Mrs. Nash has taken leadership roles in many community organizations during the past twelve years. She has been both local and regional crusade chairman for the American Cancer Society and was president of the Tryon-Polk County Republican Women.
