Phoenix Cable To Wire Green Creek

Phoenix Cable will soon begin wiring the Sunny View area of Polk County, and has decided to extend its service down Rt. 9 to Green Creek and Sandy Plains. Phoenix assistant vice president Chuck Himelrick told The Bulletin Monday.

The company, which was approved by the county to operate in the Sunny View area last fall, operates Mountains Cablevision in Lake Lure.

Himelrick said his company has finished getting permits to use the power poles in the Sunny View area from Duke Power and Rutherford Electric Association.

"We're just waiting for a (wiring) crew and some hardware," before Sunny View residents can begin getting cable service, Himelrick said.

As for the Sandy Plains and Green Creek areas, Himelrick said he spent last Friday driving the area and has asked his staff to begin mapping the area for cable service.

The Green Creek Ruritan Club can largely take the credit. The club members have been passing petitions asking Phoenix to extend its service. Petitions are out at Meg's Diner, Sandy Green Supermarket and at area churches.

"The big thing with a lot of people is sports, ESPN," said the Rev. Chuck Rinehart, president of the Green Creek Ruritans.
