Enrollment Soars At Polk Campus, I.C.C.

Enrollment in college credit classes in the curriculum program at the new Polk County Campus of Isothermal Community College has nearly tripled, it was announced by Carole Bartol, director of the Polk County Campus.

Curriculum program enrollment in the Fall, 1989 quarter in the old building was 30 students. In the Winter, 1989-1990 quarter — the first in the new building — enrollment rose to 50. Now, in the Spring, 1990 quarter there are 89 students registered in college credit classes in the curriculum program.
