## **Tryon Proposes** Lake Lanier Zoning

Tryon officials have proposed a zoning ordinance for Lake Lanier which would restrict the size of lakefront buildings.

The proposed ordinance is now in the hands of Greenville County officials, and Tryon Town Manager Barry G. Richards said he expects it will take them 15 to 20 days to review it.

Until an agreement is reached between the two jurisdictions, a moratorium is in effect on all lakefront building, unless a valid building permit was issued before the moratorium began March 13.

The Town of Tryon owns the Lake Lanier lake bed, although 14 is located in Greenville County. S.C.

Tryon officials have for some time been concerned about their ability to protect the quality of the town's drinking water. esperative when it comes to the illegal . a of portable toilets in oversized boathouses.

Many boathouses have become, in effect, dwellings and weekend party rooms, Richards said.

The ordinance proposed by the town would restrict the size of any new structures built on the lakefront, and should curb future problems, Richards said

Before a lot owner could build in the future, he would need a "lake access zoning permit" from Tryon, Richards said Under the proposed ordinance
