RABIES CLINIC

During May of this year, Polk County veterinarians will be working in co-operation with the Polk County Health Department in conducting RABIES CLINICS in Polk County. These clinics are being held in order to allow all dog and cat owners to have their pet vaccinated, conveniently.

North Carolina State Law requires that all CATS and DOGS 4 months old or older be immunized for RABIES.

The first vaccination is effective ("good") for 1 year. Booster vaccines are effective ("good") for 3 years if given ON TIME and kept UP-TO-DATE.

The RABIES CLINICS will be held in all areas of Polk County.

The COST of vaccines at the Rabies Clinics is \$5.00.

We request that those pet owners attending RABIES CLINICS properly restrain and control their pets. Dogs should be on a leash. Cats should be kept in a carrier or box or kept in cars until the time of their vaccination.

All dog and cat owners whose pets are not currently vaccinated for RABIES are encouraged to take advantage of the spring clinics. Proper vaccination protects these pets as well as owners and other people who make contact with these pets. Vaccination also should be done to comply with North Carolina State Law.

NOTICE OF PUBLIC HEARING TOWN OF TRYON

Notice is hereby given that a Public Hearing will be held by the Planning & Zoning Board at the Tryon Town Hall on the 16th of May, 1990, at 5:00 p.m. in Tryon, North Carolina, for the purpose of considering an amendment to the zoning ordinance. The proposed amendment is as follows:

Section 1608.1s (3) — Add: These are wall or ground signs only.

Section 1608.3 (a) — Change To: In all districts no more than three (3) different accessory use signs per building, with only one (1) being a ground or pylon sign, shall be permitted; however, in buildings having more than one (1) tenant, one (1) additional accessory business wall sign shall be permitted for each tenant provided the total sign surface shall not exceed ten (10) square feet in surface area."

The public is urged to be present for this important meeting. A copy of the proposed ordinance and map area on file in the Town Clerk's Office for inspection by all interested citizens.
