Weather Tuesday, high 91, low 20, hum. 66%. The precipitation in July was above average at 7 inches. The average is 5.14 inches.

For the year so far, the Thermal Belt has received 6.1 inches more rain than the average to date. So far in 1990, 46.04 inches of rain has fallen.
