You may recall that the Board of Education took the Board of Commissioners to court citing a lack of adequate funding. A jury of 12 Polk taxpayers agreed with the school board.

That's why county taxpayers will be receiving a second tax bill this year.

And on it will be printed: "1990 Supplemental Tax Bill, as mandated by the Superior Court." That message was decided upon last week on a motion by commissioner Henry Huntsinger, supported by Rachel Ramsey and Ken Faulkner. They want to be sure everyone knows that they didn't support the tax increase for schools.
