Ann Whitmire Profiled

Ann Whitmire, candidate for the Polk County Board of Education, is running unopposed from Cooper's Gap Township. Her profile published below completes a series of profiles of every candidate for the school board and the Polk County Board of Commissioners in the Bulletin over the past two weeks. Voters go to the polls tomorrow.

Unopposed Sunny View candidate for the Polk County Board of Education Ann P. Whitmire said she would like to be part of "making a difference in education" for Polk County.

A retired teacher, Whitmire has already visited every school and the Stearns Education Center, and as a school board member, she plans to participate in every school's functions and be a school volunteer.

Polk County's educational strength is the dedication of its teachers and administrators to implement instructional programs in the classroom that enhance learning opportunities, Whitmire said.

One of the school system's weaknesses is low scores on standardized achievement tests, she said. Whitmire said these scores can be improved by beginning early in the elementary schools with skills to develop critical thinking. She said she also believes standardized tests should be given periodically, even in the high school, so that students have exposure to this type of testing
