The program for the third annual Foothills Regional Horse Seminar is set and area horsemen will have a chance for more equestrian training. This year the two-day event is being relocated to the Tryon Fine Arts Center in Tryon. The date for the seminar is January 17 and 18.

The topics for this year's program cover a wider assortment of ideas. Equine health regulations, insurance requirements for horse owners, dealing with area horse health problems and equine feed analysis are just a few of the topics to be discussed in the January workshop.
