#### Final Sign Ordinance **Draft Due April 1**

The sign ordinance being drafted for Polk County by a committee of area residents is "coming together," committee chairman Leo Baird told the Polk County Board of Commissioners Monday night.

Baird said in addition to regulations for "off-site" signs, the newest draft of the ordinance includes regulations for "on-site" signs.

Off-site signs are those which advertise businesses or services not offered in the same location as the sign.

Baird told the board that his committee is now meeting weekly, and he said he hopes a final draft will be ready for the board by April 1st.

The county enacted a one year moratorium on all new, off-site signs last August to give the sign committee time to complete its work.
