Parris says it was Giles Pearson who first found the tall tree with the lavender blossoms growing in the Pacolet Valley. But it wasn't until 20 years later, when a botanist from Brown University arrived, that the odd tree was identified.

According to Parris, the tree was first brought to America 100 years ago, and "escaped" into the wild. Parris says a single paulownia produces 21 million seeds and a seedling grows 20 feet in a year.
