Two Youths Die In Sunny View House Fire Tues.

State Bureau of Investigation and Polk County Sheriff's officers on Wednesday were still investigating the scene of a fire which claimed two young girls' lives Tuesday night.

Marie Stafford, 14, and Connic Stafford, 11, were found in a back bedroom of the burned out one-story house on County Line Road in Sunny View.

Emergency personnel received a call about the fire at 9:30 Tuesday night, according to the Sheriff's Department. Sunny View firemen were the primary agency fighting the fire, with help from Mill Spring and Green Hill firemen.

Sue Pack of the Sheriff's Department said investigators talked with the girls' grand-mother who said she had talked with the girls at 9 p.m. and they said they were preparing for bed.

The girls lived with their mother, Roseanne Thompson, who Pack said was not at home at the time of the fire. Thompson works a night shift, Pack said.

The bodies of the girls were being sent to the state coroner for an autopsy Wednesday. Pack said no charges have been brought in the case, and it had not yet been determined how the fire began.
