The weather Thursday, high 74, low 50, hum. 45 percent. In April, 5.37 inches of rain fell, just .06 inches more than average. It was a lot wetter last April, when 8.18 inches of rain fell. So far this year, 21.23 inches of rain has fallen, 2.03 inches less than average. The high temperature in April was 88 degrees, registered on April 24, and the low was 28 degrees, registered on April 4th.

The polls open tomorrow at 6:30 a.m. and close at 7:30 p.m. Voters in Polk County will choose candidates from each party to run in the general election in November. Choices include President of the United States, U.S. Senator, Governor, Lt. Governor, Superintendent of Public Instruction, judges and other statewide officials.

On the local scene, Democrats and Republicans will choose county commissioner candidates and Democrats will choose a Register of Deeds candidate.
