## Hospital Trustees Vote Saturday Ruled Invalid

A secret ballot vote taken Saturday by St. Luke's Hospital Board of Trustees on seven recommendations from a special committee is not legal under state law.

Saturday's special meeting was called to vote on the recommendations of a special Oversight Committee created to look into complaints and recommendations made by the St. Luke's Medical Staff two months ago. Jeanne Martin, Dr. S.L. McCormack, Donna Janes, John Elliott and Robert Bielaski were appointed to the Oversight Committee which was "charged with dealing with the issue of administration and how to structure and improve communication between the board of trustees and the medical staff," said Trustee Chairman Joe Claud.

First recommended by the Oversight Committee was that the President of St. Luke's Hospital, Thomas Bradshaw, remain in his present position, and "we further recommend that future relationship with the medical staff be objective, free from any personal differences, and forthright."

However, this and the other six recommendations made by the Oversight Committee will be re-submitted to the Hospital Trustees for vote . . . but when depends on summer vacation
