

Woman Wins Suit Against Bank

money leaving a \$147 outstanding balance on the loan.

When Wall tried to collect the debt, the suit says, Mrs. Hairston was in bad financial shape because she had been laid off from her job, but she promised to pay the bank the remaining money as soon as possible.

Wall, the suit says, attempted to cash the check he received in the mail. That check was worthless. The suit says he had no business taking out the warrant because Mrs. Hairston had originally told him it would be worthless and that she did not have enough money to cover both checks. The worthless check war-

rant Wall took out against her was for the check she mailed in February, the suit says, and on June 27 Judge Abner Alexander found her not guilty.

Mrs. Hairston's original suit was filed on Nov. 20 and the Notice of Dismissal was filed with the Clerk of Superior Court at 4:18 p.m. on Dec. 22.

Arrests Net Guilty Pleas

Two persons who were arrested last week during a drug roundup have pleaded guilty and have been sentenced to prison and another man was set free because he was the wrong man.

One of the men arrested was indicted under the name of Bernard Jackson, 33, of 1521 E. 17th Street. An assistant district attorney said the man arrested under that name told authorities that his real name was Clarence Bernard Robinson.

The prosecutor said that while police were looking for Robinson, an SBI agent who bought the drugs was present and told police that Robinson was not the man who sold him the drugs.

Evidently, the prosecutor said the man who sold the agent the drugs, used a phony name. The charges against Robinson were dropped.

Hezekiah Jackson, 21, of 612 Mock Street was sentenced to four to five years in prison on two counts of conspiring to sell heroin and two counts of possession. He was also sentenced to 12 to 18 months in prison on a separate charge of breaking into a car parked at the Holiday Inn Central on Oct. 21.

John Michael Clement, 23, of 3031 Bon Air Avenue, was sentenced to a year in prison on a charge of conspiring to sell heroin. Since he pleaded guilty, the state dropped two other drug charges against him.

They were taken to Forsyth Hospital.

A policeman spokesman said they were injured when the cars they were riding collided at an intersection where Corporation Parkway empties onto Clemmons Road. Other details were not available.

Rescue workers worked several minutes trying to free one of the women from the wreckage of her car. Attempts failed to revive her.

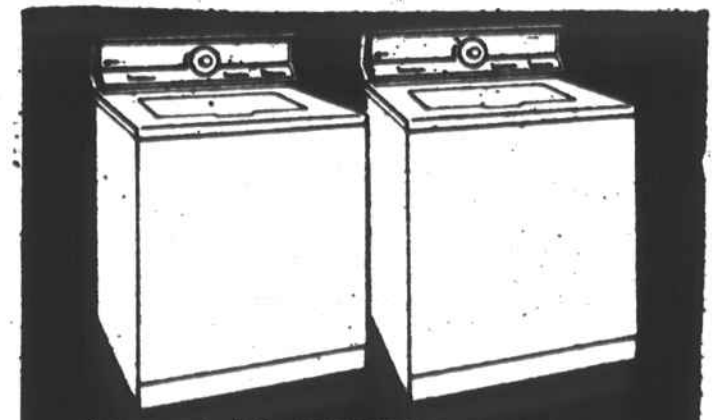
