Gov Offers Reward In Two Murder Cases

Governor Jim Holshouser has offered two \$2,500 rewards for information leading to the solutions of the murder of Frank Marion Jackson of Cumberland County and Joseph Exton Bird, Jr., of Randolph County.

Jackson was found in his car just off Highway 301 near Fayetteville between 9:00 and 9:30 p.m. on June 7, 1976. Death resulted from a bullet wound in front of the right ear.

On June 21. 1976, at approximately 11:30 a.m., Bird was found dead in his pickup truck. He had been shot twice in the head and had been robbed of approximately \$1,500.

The rewards will be paid to anyone furnishing information to the Sheriff's Departments of Randolph and Cumberland Counties or the the State Bureau of Investigation which leads to the arrest and conviction of the person or persons responsible for the murders.

Bishop Demorie Robinson, pastor of New Hope Deliverance and Miracle Center, Inc., is planning to move his church to the Guilford County area. The planned move is scheduled for the end of this year or in January of next year. The church headquarters will

remain in Winston-Salem and plans are being drawn up for a temple to be built here within the year.

So far, church services have been held at the Winston-Salem Convention Center to the tune of nearly \$200 a Sunday for space rental, said a spokesman for the center.

Free Service Stalled Pending Co. Approval

After nearly eight months of waiting, it appears as though the Joseph Waddell People's Free Ambulance service will have to wait a few more days to get underway.

The service was supposed to start on Tuesday (September 28th), but could not do so because they still had not received authorization from the county. The service has to show the county that its insurance is up to date, that their ambulance and crews are certified by the state, and that there is a direct line of communication with the county ambulance service.

Nelson Malloy, a director of the service, said in a telephone conversation, that is was simply a matter of sitting down with county officials and presenting the proper papers showing that they are certified by the state and that the insurance is current. He said he did not forsee any problems and thought the service would probably begin Thursday.

"Everything the county has asked for has been compiled with and now its just a matter of letting them see it."

At a press conference called last week to announce that the service had been refranchised and was ready to start operating, Malloy lamented that it had been a long hard struggle. He also indicated that while there had been a great deal of support from the community, there were factions of the community that

sought to block the service's efforts to start again.

Boosted by a \$10,000 grant, the third such grant, from the Episcopal Church, the service will be trying to raise an



Pulliam said he was on his way back to work when he noticed the Monte Carlo at Shelton's Gulf at 16th and Liberty Street. When he approached the car, Thomas reportedly ran behind the station, headed south towards 15th Street.
