**U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT
INVITATION FOR APPLICATIONS FOR SECTION 202
FUND RESERVATIONS**

To Whom It May Concern:

The Department of Housing and Urban Development invites applications for newly constructed and/or substantially rehabilitated housing units under the Section 202 Direct Loan Program for Housing for the Elderly or Handicapped. This notification is based on a tentative allocation of funds which is subject to modification.

Section 202 direct loan authority in the amount of \$5,607,000 for metropolitan and \$6,346,000 for non-metropolitan areas is tentatively being made available to the Greensboro Area HUD Office jurisdiction to finance an estimated 190 units for metropolitan areas and 210 units for non-metropolitan areas. The areas listed below, within this HUD Office jurisdiction, have been identified as those in which additional housing for the housing assistance plans. Applications for the designated areas below will be evaluated first, and only in the event that an insufficient number of approvable applications are received for the designated allocation areas will applications for other areas be considered for approval. Notwithstanding the above preference for applications received for a designated allocation area, applications for housing designed exclusively or primarily for the non-elderly disabled or handicapped for any area will be accepted and evaluated. Prospective applicants are also advised of the existence of factors (other than the funding capacity of the Greensboro Area Office) which will limit the number of approvable units for any one application.

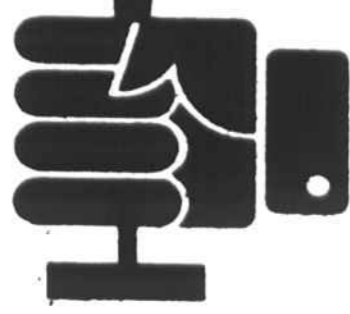

TREMENDOUS TRIFLES

THE COW'S DIET THAT MAKES FILM POSSIBLE
Strange it is that the development of photography—and the movies, too—depended on the fact that cows like to eat wild mustard. Here is another of those seeming trifles that have unexpected results. Here is the explanation.

Photographic film, without which we would have neither snapshots nor movies, is made of gelatin into which minute grains of a chemical called silver bromide have been embedded. But until the significance of cows and mustard was understood, no one knew why one batch of gelatin when treated with silver bromide would produce sensitized film while another batch, similarly treated and produced under identical conditions, was useless for photography.

Gelatin is made from the skins of calves. First, slabs of calfskin are treated with lime for several weeks. Next, these slabs are washed with acid and water. Then they are boiled. Finally, the gelatinous liquid is cooled to a jelly and dried. The final result is gelatin.

In an effort to discover why only some batches of gelatin would become sensitized when treated, research scientists traced back the steps of manufacture in their laboratories. In this way it was found that the acid and water solutions used to wash what turned out the good gelatin contained a residue that the other did not. After several unsuccessful attempts to identify it, that residue was recognized as being wild mustard! Only the skins of animals that had been eating wild mustard and thus absorbed mustard oil in their systems produced sensitized photographic film!

Once the secret was learned, technicians were able to treat the product with synthetic mustard oil and thus make all batches of gelatin good for their purposes. But, had it not been that the appetite of cows and calves included a liking for wild mustard, there would have been no photographs and no movies.

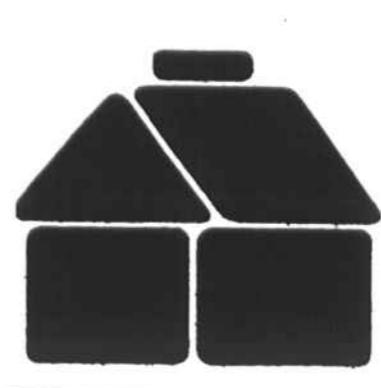

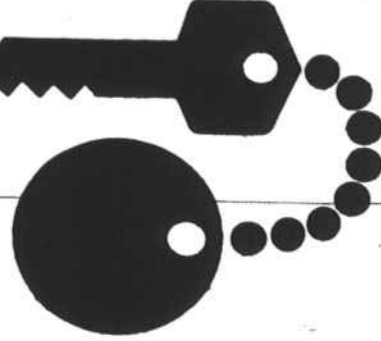
