Masons Contribute Money To Assist

The Illustrious Brother Clyde Alexander, vice president of the Mountain Region of United Supreme Council 33 of the Ancient and Accepted Scottish Rite of Freemasonry, presented a check in the amount of \$300 to the Association for Sickle Cell Disease Inc. in Charlotte recently.

The \$300 contribution represents the third annual financial gift to the association to assist in continuing to provide free services for persons affected by sickle cell disease and related genetic disorders. Such contributions are needed by the association due to drastic cutbacks and deminishing funds.

Sickle cell disease is a

worldwide problem, a genetic disorder characterized by an abnormal hemoglobin molecule predominantly affecting blacks in the United States and Africa and, to a lesser extent, Latinos and selected populations generally adjacent to the Mediterranean Sea and Indian Ocean.

It has been determined that one in every 400 to 600 American blacks are affected with sickle cell anemia at birth (50,000 of the nation's 22 million American blacks). Some two million American blacks have sickle cell trait. If two such carriers mate, their offspring will have a one in four chance of hav-
