toured Vietnam to boost the morale of American troops and always volunteered for charities, including sickle cell anemia groups that didn't know his daughter had the disease.

Stargell was born in proverty to a black father and Seminole Indian mother in Oklahoma. He played baseball in the desert and, in high school, coaches urged scouts to sign him up. At the time, few scouts would gamble on a black, especially one with Indian blood.

"Nothing else dealing with either baseball or life was as difficult for me to handle as racism," says Stargell, recalling his early days in the minor leagues. The toughest coaches are in the lowest ranks of the minors. Several perish because of the intensity level. Others fall apart because of personal, psychological or physical reasons."

That wasn't all. Stargell recalls walking to his first game in Texas: "A white man, hiding around a corner, jumped in my path. He had a shotgun in his hand. The cold metal barrels pressed tightly against my temple. I began to shake like a leaf. The gunbearing bigot never flinched. 'Nigger,' he told me. 'if you play in that game tonight I'll blow your brains out," Stargell went out later and played. "But I still felt the touch of the cold barrels today. It's a feeling that has never left me."
