

Par Degrattinrealds, Foundar Sociologist Dr. Robert Staples wrote, "A well-known black leader in the San Francisco Bay area has advocated the institution of a personals classified section Such a service, he says, would allow members of our community a means of getting in touch with suitable persons who meet their selection criteria. It would be a positive service to black people who don't relate well to or don't like to seek new relationships with new people within the context of singles' bars."

I can certainly agree with the gentleman. There are numbers of black men and women who are looking for sensitive and intelligent mates but find it difficult to meet them through the "normal" means. No matter what's said about the personals, they are an effective way of meeting new friends. The personal ad is a new and socially acceptable avenue that brings eligible singles together.

As "Ziggy" so eloquently put it, "... Loneliness isn't such a bad thing ... except when you don't have anyone to share it with ..."
