## Who killed eight-year old Adam Mann?

On March 5, 1990, in New York City, five-year-old Adam Mann was beaten to death for eating a piece of cake. His mother and father were both indicted for murder in his death. The autopsy revealed Adam had been battered for years. Over 100 injuries were observed on the child's body; at one time, the doctor said, every bone in his body had been broken.

In "Who Killed Adam Mann?" airing Tuesday, December 3, at 9 p.m. (check local listings), Frontline investigates the long history of child abuse in Adam Mann's family and reveals a documented record stretching back seven years — of how New York City's child welfare system failed to protect Adam and his three brothers.

This unique record exists because the Mann children and their parents were filmed earlier for a 1985 Frontline documentary on child abuse produced by Carole Langer.

"When we first began filming the family back in 1983," says Langer, "there were physical signs of the children having been beaten. Emergency child abuse reports had also been filed; a caseworker had already been assigned. At the time the program was broadcast in 1985, the children were removed and placed in foster homes. We didn't learn when the children were returned to their parents of why. Now we know."

This Frontline investigation, produced by Langer, draws on her earlier access to the family and their relatives and on interviews with social workers and psychiatrists who tried to help. This report tracks the numerous child abuse reports filed by doctors and social workers, the decisions of the family's caseworkers, the treatment provided the mother, and the growing record of injuries to Adam and his three brothers, Keith, Peter, and Larry.

Among Frontline's findings: (1) eight-year-old Keith Mann, in one fourteen-month period, suffered a ruptured spleen, a perforated intestine, liver damage, and fractures of the face, ribs, arms, and skull; (2) seven-year-old Larry Mann had been hospitalized several times. He had suffered a broken leg, a broken wrist, and his body was covered with multiple fractures; and (3) tTen-year-old Peter Mann attempted suicide and has said he wants to go to heaven like his brother Adam. But despite numerous child abuse reports and a growing file documenting hospitalized injuries, the caseworkers, with few exceptions, decided there was no danger and allowed the children to remain with their mother.

"I remember the doctors in the hospital. They were angry with us and would say 'You have to do something about it,'" says Helen Henighan, a social worker who worked for a private child-care agency. "We kept filing reports and trying to do something to have the kids removed. But it just didn't seem to get anywhere."

Following one episode of serious abuse, the caseworker failed to visit the family for six months. He only returned when another emergency child abuse report was filed.

This Frontline report also examines the expensive, one-year rehabilitation program ordered by the court for the mother, Michelle Mann, which failed to solve her problems with her children. "There was no staff psychiatrist . . . the amount of psychiatric time was extremely limited," says Dr. Mark Nessel, who was the senior consulting psychiatrist for the program. Another part-time psychiatrist, Dr. Barbara Munk, says Michelle Mann frequently hit her children while in the program. "The staff was frustrated and I think nobody could get hold of her to help her," says Munk."Who Killed Adam Mann?" also investigates why the family was left completely unmonitored for long periods of time by New York's Child Welfare Administration.

At one point, there was a twoyear gap in which no one checked on the children. During that time, the abuse continued.

"Adam's body was so messed up," says Verna Chisholm, Adam's aunt. "She [Michelle] didn't take him to the clinic. She would take the other kids to the clinic and make believe what was wrong with Adam was wrong with the others who didn't have too many marks."

When the caseworker was asked why there was a two-year gap in which she had filed no reports, she said she had transferred the case to another agency. But after learning the case hadn't been transferred, she became disgusted and put it in the file without any further action.

No disciplinary action was taken against the caseworkers or their supervisors.

In February 1991, Adam Mann's father pled guilty to manslaughter in his son's death. Adam's mother pled guilty to a separate charge of assault. Both are now in prison in New York.

Officials of the Child Welfare Administration declined to be interviewed for this report, citing state laws of confidentiality governing child abuse cases.

"In the U.S., some twelve-hundred children will die this year of neglect and abuse," says Frontline Executive Producer David Fanning, "and New York City's problems are a microcosm of the nation's. This report raises serious questions about whose interests really are being protected by

# Judge rules police used excessive force in killing of blacks at protest

JOHANNESBURG, South Africa (AP) — Police who killed 12 blacks while breaking up an African National Congress protest used excessive force by firing hundreds of bullets, a judge ruled.

Justice B. O'Donovan said a police claim of self-defense when the officers fired on the crowd March 24, was not plausible because more than 250 rounds of ammunition were used. in the Rand Supreme Court, said the "slaughter exceeded the limits of self-defense." A police officer also was killed in the incident.

The inquest's finding was referred to the Attorney General for possible investigation and prosecution. The inquest into the deaths in the black township of Daveyton, east of Johannesburg, is part of government efforts to curb what critics consider to be excessive use of force by police.


The ANC, the main black political organization, has charged break up peaceful political meetings to suppress the opposition. Police commanders deny the charge.

Police opened fire on the crowd of ANC supporters in Daveyton after ordering the crowd to disperse. Members of the crowd claimed they were trying to protect themselves from the rival Inkatha Freedom Party.

Violence erupted when two shots were fired as police began searching protesters for weapons, the court said. Sgt. Jan Petrus van Wyk was then stabbed to death by
