Sealed bids will be received by The Winston-Salem/Forsyth County Board of Education in the Auditorium of the Administration Building, 1605 Miller Street, Winston-Salem, N.C., until 2:00 p.m., February 23, 1993, at which time they will be publicly opened and read. Plans and Specifications for the proposed work may be examined at the office of Consultant Engineering Service, Inc., 125 Fayette Street, Winston-Salem, North Carolina and the AGC and Dodge Plan Rooms, Greensboro, North Carolina. Bonafide bidders may obtain copies of the proposed Contract Documents at no charge at the office of Consultant Engineering Service, Inc., Engineers, 125 Fayette Street, Winston-Salem, North Carolina 27101. Copies of the proposed Contract Documents are limited to one (1) set per bidder. Additional sets may be purchased from the Engineer at a non-refundable rates of \$1.00 per sheet of drawings and \$20 per page of specifications or full sets of plans and specifications at \$10.00 per set. Sub-Contractors and material suppliers may obtain copies of Documents at the same non-refundable rates as listed above. Bidders shall return bid documents to engineers with their bids. Bids shall be taken for Mechanical Work and Electrical work to be performed.

All contractors are notified that they must be licensed under prevailing N.C. State laws. The Contractors are hereby notified that all public laws pertaining to receiving and awarding contracts will be observed.

In consideration of the Owners receiving his bid, each bidder agrees that no bid may be withdrawn after the scheduled closing time for the receipt of bids, for a period of up to forty-five (45) days, except as provided by NC State law.

A Performance Bond and Labor and Materials Payment Bond will be required of the successful bidder in any amount equal to 100% of the Contract price.

Each proposal shall be accompanied by a cash deposit or a certified check on some bank or trust company insured by the Federal Deposit Insurance Corporation in an amount equal to not less than 5% of the proposal, or in lieu thereof, a bidder may offer a bid bond executed by a corporate surety licensed under the laws of North Carolina to execute such bonds, conditioned that the surety will upon demand forthwith make payment to the obligee upon said bond if the bidder fails to execute the contract in accordance with the bid bond, and upon failure to forthwith make payment, the surety shall pay to the obligee an amount equal to the amount of said bid bond. The deposit shall be retained if the successful bidder fails to execute the contract within 10 days after award or fails to give satisfactory surety as required herein.

The Owner reserves the right to reject any and all bids, or to accept the lowest legal bid deemed in the best interest of the Owner, and to determine low bidder in case of tie bids.
