
Siecor Corporation to Build New Plant

Womble Attends Washington Meeting

Alderman Larry Womble of the Southeast Ward was in Washington recently to attend the first major meeting for municipal government leaders to take stock of President Clinton's national economic program and to plan a strategy to make it work in America's cities and towns.

More than 3,000 local government officials took part in the National League of Cities' annual Congressional-City Conference, which took place as Congress was preparing to take up the President's initiatives.

President Clinton personally brought his blueprint for change to the meeting, and in a speech to the delegates on March 8 said the success of his plan depended upon everyone taking responsibility for building a stronger America.

NLC President Donald M. Fraser, mayor of Minneapolis, told the delegates that breaking the political gridlock in Washington and launching a rigorous and sustained effort to strengthen the nation's economic future required grassroots support as well as presidential leadership.

Although the state offered no financial incentives, it will provide specialized training for Pepsi employees at the local community college. In addition, Hunt personally lobbied Pepsi-Cola executives and met with top officials in the Governor's Office to facilitate the deal.

"North Carolina has a great deal to offer Pepsi," said Janice Montle, senior vice president for business strategy and transformation and chief financial officer at Pepsi. "Given our 100-year legacy in the state, we're especially proud to establish such a significant presence

Don't Delay Your Tax Refund

Take a little time to check your income tax return. This can save you a lot of time waiting for your refund or the use of your money.

Mistakes such as income reported on the wrong line and missing schedules slow down the processing of your return. A quick check to see if the return is complete, correct and easy-to-read can eliminate problems for you before they occur.

When you have completed your return check the following: · Are your name and social security number on each supporting schedule, e.g. Schedule A&B.

· Are the names of your dependents and social security numbers of those one year and older on your return?

Is your arithmetic correct?

 Did you claim the correct standard deduction, unless you itemized for your filing status? Especially double-check if you can be claimed as some else's dependent?

· Have you used the right figure from the proper column in the Tax Table?

. Do you qualify for the earned income credit (EIC)? You don't want to miss a tax benefit that you are entitled to, particularly if it will provide a greater refund to you.

• If you made estimated tax payments during the year, have you made the correct entry for your payments on your Form 1040 or 1040A? • Are all Forms W-2, "Wage and Tax Statement," and supplemental

tax forms and schedules attached? Did you sign and date the return? If you are married and filing a joint return, did your spouse also sign and date the return?

. Did you use the peel-off label and pre-addressed envelope? If the label is not correct, carefully make the proper changes on the label. · Did you make yourself a copy of the Federal and state income tax

If you are unable to file your income tax return by the April 15 deadline, file for an extension. However, to make the filing extension valid, you must have paid by the due date, April 15, at least 90 percent of your total tax liability for the year for which you are trying to obtain the

filing extension. If you don't include 90 percent of the income taxes due with the extension form, your income tax return will be considered a late-filed return. As a result of late filing, penalty will be assessed, as well as interest on the late payment. Therefore, it is important that you make a good estimate of how much you will owe and include that amount with the extension form that you will mail to the IRS. You should not be concerned about overpaying your taxes; the IRS will give refund the overpayment if your estimate is high.
