Attention is called to the provisions for equal employment opportunity. Payment of not less than the minimum salaries and wages as determined by the Department of Housing and Urban Development is required.

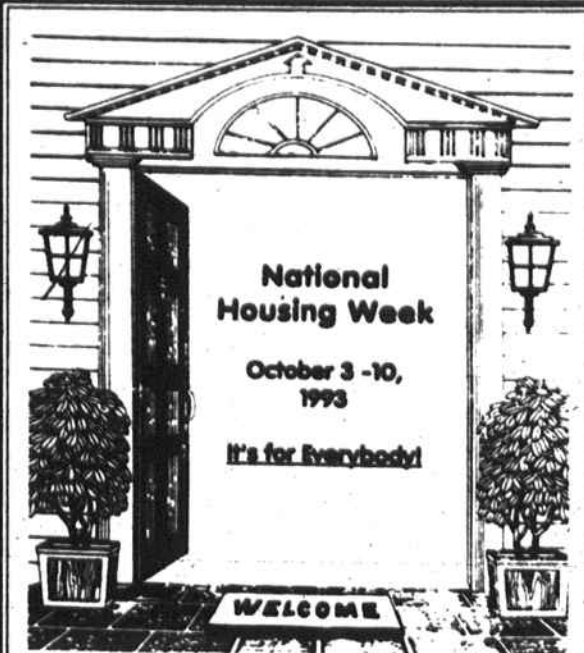
The Housing Authority reserves the right to reject any and/or all bids, to waive informalities, and to select a bid other than the low bid should it be deemed in its best interest.
