CONCERNING MEETINGS TO BE HELD REGARDING THE SITE STUDY APPLICATION FOR THE HANES MILL ROAD LANDFILL

TO THE GENERAL PUBLIC:

PLEASE TAKE NOTICE that the City-County Utility Commission, a joint agency of the City of Winston-Salem and Forsyth County, and the City of Winston-Salem have submitted a Site Study application to the North Carolina Department of Environment and Natural Resources (NCDENR) as required by 15A-13B.1618 of the North Carolina Administrative Code. The purpose of this submittal is to begin the process of seeking NCDENR permits to construct and operate the Hanes Mill Road Landfill expansion, a proposed municipal solid waste landfill facility (MSWLF) to be located west of the existing MSWLF.

At the regular meeting of the Winston-Salem Board of Aldermen on January 18, 2000, at 7:30 p.m. in the Board of Aldermen Chambers at City Hall, Winston-Salem, North Carolina, a Public Informational Meeting will be held to inform the community of the proposed waste management activities described in the facility plan contained in the Site Study application.

In addition to the public informational meeting on January 18, 2000, the staff of the City/County Utility Commission will also make another presentation of the waste management activities described in the proposed facility plan contained in the Site Study application on January 20, 2000 at 7:30 p.m. at Northwest Middle School. The public is also invited to attend this meeting to learn of the plans proposed for the landfill expansion. A question and answer session will be provided.

This Site Study application is entitled *Hanes Landfill Expansion Site Study* and may be viewed prior to the meeting at the following locations: (1) City/County Utility Commission offices, Suite 460, Liberty Walk Plaza Building, Winston-Salem, North Carolina; (2) Forsyth County Public Library, Main Branch, 660 W. Fifth Street, Winston-Salem, North Carolina; and (3) Forsyth County Public Library, Rural Hall Branch, 7125 Broad Street, Rural Hall, North Carolina. The Site Study application may be amended and supplemented from time to time.

All requests for appropriate and necessary auxiliary aids and services must be made, within a reasonable time prior to the hearing, to Angela I. Carmon, The City's ADA Coordinator, at 727-2056 or TDD 727-8319.
