NOTIFICATION OF INTENT TO ISSUE A
NPDES WASTEWATER PERMIT

On the basis of thorough staff review and application of NC General Statute 143.215.1 and 15A NCAC 02H.0109 and other lawful standards and regulations, the North Carolina Environmental Management Commission proposes to issue a National Pollutant Discharge Elimination System (NPDES) wastewater discharge permit to the person(s) listed below effective 45 days from the publish date of this notice.

Written comments regarding the proposed permit will be accepted until 30 days after the publish date of this notice. All comments received prior to that date are considered in the final determinations regarding the proposed permit. The Director of the NC Division of Water Quality may decide to hold a public meeting for the proposed permit, should the Division receive a significant degree of public interest.

Copies of the draft permit and other supporting information on file used to determine conditions present in the draft permit are available upon request and payment of the costs of reproduction. Mail comments and/or requests for information to the NC Division of Water Quality at the above address or call Dina Sprinkle (919) 807-6304 at the Point Source Branch. Please include the NPDES permit number (below) in any communication. Interested persons may also visit the Division of Water Quality at 512 N. Salisbury Street, Raleigh, NC 27604-1148 between the hours of 8:00 a.m. and 5:00 p.m. to review information on file.

Taylor & McChesney, LLC [3600 Country Club Rd, Suite 200, Winston-Salem, NC 27104] has applied for renewal of permit NC0088242 for its Conrad Farm WWTP in Forsyth County.

This permitted facility discharges treated domestic wastewater to Mill Creek in the Yadkin-Pee Dee River Basin. Currently dissolved oxygen, ammonia nitrogen, fecal coliform and total residual chlorine are water quality limited. This discharge may affect future allocations in this portion of Mill Creek.


Aqua North Carolina, Inc. Cary, North Carolina has applied for renewal of NPDES permit NC0063720 for its Forest Ridge Subdivision WWTP in Forsyth County. This permitted facility discharges treated wastewater to Blanket Creek in the Yadkin-Pee Dee River Basin. Currently ammonia nitrogen, total residual chlorine, and BOD are water quality limited. This discharge may affect future allocations in this portion of the watershed.

The Winston-Salem / Forsyth County Board of Education [4897 Lansing Drive, Winston-Salem, NC 27105] has applied for renewal of permit NC0034827 for the Old Richmond Elementary School WWTP. This permitted facility discharges treated domestic wastewater to an unnamed tributary to Fries Creek in the Yadkin-Pee Dee River Basin. Currently BOD, ammonia nitrogen, dissolved oxygen and fecal coliform are water quality limited. This discharge may affect future allocations in this portion of Fries Creek.
