This transportation assistance allows for the individual to reside for longer periods in their homes, thereby enhancing their quality of life. For the purpose of EDTAP, an elderly person is defined as one who reaches the age of 60 or more years. A disabled person is defined as one who has a physical or mental impairment that substantially limits one or more major life activities, an individual who has a record of such impairment, or an individual who is regarded as having such impairment.

2. Employment Transportation Assistance Program is intended to provide operating assistance for transitional Work First; Workforce Development Programs and general public employment transportation needs.

3. Rural General Public (RGP) Program funds are intended to provide transportation service to individuals who are not human service agency clients and live in non-urbanized areas.

The purpose of this city of Winston-Salem Primary Election will be to nominate one Democratic candidate for the following office: Council Member from each of the following wards: North, Northeast, East, South, Southeast and to nominate one Republican candidate for the following office: Council Member from each of the following wards: Northwest and Southwest.

The voting places may be obtained by calling the Forsyth County Board of Elections. Polling Places in most election precincts are physically accessible to the elderly and handicapped. Any Voter is entitled to assistance in casting votes from the person of his or her choice. In those instances where polling places cannot be made accessible, elderly and handicapped voters may vote ballots at curbside or request assignment to an accessible facility for the purpose of voting.

The last day for an in-person registration of those not previously registered is Friday, August 21, 2009. The last day on which qualified voters who have moved their residence from one precinct to another precinct within Forsyth County may transfer their registration in person is also Friday, August 21, 2009. Change of address using a Forsyth County voter card must be received by August 21, 2009 if delivered in person and postmarked by August 21, 2009 if mailed, in order to be valid for the September 15, 2009 Municipal Primary Election. Otherwise, a person may transfer their precinct on Election Day according to the provision of G.S. 163-82.15 (e). Mail-in registrations must be postmarked by August 21, 2009 to be a valid registration for the September 15, 2009 Municipal Primary Election. If the applicant or another individual delivers a mail-in form to the Board of Elections, it must be received by 5:00 PM on August 21, 2009. Registration forms by mail are available from the Board of Elections office, public libraries, various government offices, registration drives, and other public locations. Contact the Forsyth County Board of Elections office for a complete list.

Qualified voters who are not certain whether they are registered should contact the Forsyth County Board of Elections. The registration records will be available for public inspection by any elector of Forsyth County during regular office hours and days of the Forsyth County Board of Elections, 201 N. Chestnut St., Winston-Salem, North Carolina. (Monday - Friday, 8-5).

Mail out no excuse absentee ballots will be allowed in this election for all voters. One-Stop, no excuse absentee voting will take place at the Forsyth County Board of Elections office, August 27, 2009 thru September 12, 2009. Hours are 8:00 AM until 5:00 PM on August 27th, 28th, 31st, September 1st, 2nd, 3rd, 4th, 8th, 9th, 10th and 11th and 10:00 AM until 1:00 PM September 12, 2009. You may contact the Forsyth County Board of Elections office for information on additional sites and times.
