TAKE NOTICE that a Petition to Terminate Parental Rights seeking relief against you has been filed in the Juvenile Court department of the District Court in Winston-Salem, Forsyth County, North Carolina. The nature of the relief sought is termination of your parental rights with respect to the female juvenile born to "Lashonda," an African-American woman, on or about January 28, 2009 in Winston-Salem, Forsyth County, North Carolina.

The father of the juvenile is alleged to be an African American man in his early forties; about 6'2" tall with brown skin, black hair cut low and brown eyes who met the mother at a club and took her to the Inn Keeper motel in Winston-Salem, North Carolina in late Spring of 2008.

You must answer the Petition or otherwise make defense within 40 days after July 23, 2009, exclusive of that date. You are entitled to attend any hearing affecting your rights. You are entitled to appointed counsel if you cannot afford to hire a lawyer to represent you, provided you promptly contact the Clerk of Superior Court to request counsel. Upon your failure to answer the Petition within the time prescribed, the Court will issue an Order terminating your parental rights.
