

It will be seen by the following resolutions passed by the Magistrates of Union county, at a Special Court, that they condemn the action of the Legislature in appropriating \$20,000 for vaccidating the people. We expressed the opinion that the measure was a deless one as soon as we heard the Legislature had adopted it, and we think the action of the Union county Justices right and proper." It has always leen the case in this State that any one who wanted to be vaccinated could have it done whether they had the money to pay for it or mit. Within the past two months thousands have been vaccinated gratis by physicians and others who understood the simple operation, and we do not believe there was any necessity for appropriating a large sum from the State Treasury, for the purpose of employing salaried offi-

March 9th, 1863 Resolved by the Justices of the Peace of said Coun-ty. (a majority being present.) The adoption of this resolution was moved by Dr.

Jas. J. Williams, and unanimously carried. On motion, the Western Damocrat is requested to publish this action of the Justices of Union county, and other papers copy.

General Pillow.

Gen. Pillow recently made a speech to planters in Alabama, to induce them to permit their slaves to enter Government employ as teamsters, etc. To show that he was not asking them to make sacrifices that he himself would not make, he told of his own losses-400 negroes, four gin houses worth \$10,000 each, \$100,000 pounds of bacon, 2 000 hogs, 500 head of cattle, his houses and plantations destroyed and desolated, and 2,100 bales of his cotton burned by his own Government.

He stated that Gen. Sherman had written him a letter, couched in very polite language, offering to re-tum his negroes to him, and to indemnify him for all his losses, if he would abandon the Confederate service. His answer was:

"General, whilst I thank you for your courteous letter, let me say to you, the property your Gevernment has taken from me was my own. Your Gov-ernment has the power to rob me of it, but it is too poor to buy me.'

Noble General! if all the sons of our suffering country would in like spirit Pillow her head, she would soon rest in security.

The London correspondent of the Manchester Gualdian says that the Confederate loan has been all freely taken on the Continent, and that England will have no more of it that came from a foreign market,

The Polish insurrection was exciting great attention in the Cabinets of the leading Powers.

The Russians were defeated by the Poles after an engagement of five hours at Mallagosse. The town was reduced to ruins.

In Liverpool on the 28th, the Cotton market was quiet, but steady; Consols, 921.

The majority in New Hampshire against the Democtatic candidate for Governor was about 700. One Democrat was elected to Congress.

Confederate Congress. RICHMOND, March 17.

SENATE resumed the consideration of the Supreme Court bill. Mr. Yancey delivered a lengthy argument to show that the constitution did not grant to the Supreme Court appellate jurisdiction over the State courts, or revisionary power except in cases where the State had levied an import. At the close of his remarks the Senate went into executive session on the impressment bill, which was referred to a committee of conference.

The House was in secret session.

REVOLUTIONARY ITEMS -On the 6th of October, 1775, a resolution was passed recommending to the several provincial assemblies, and committees of public safety, to arrest and secure any person in their respective colonies whose going at large might in their opinion endanger the safety of the colony or the liberty of America.

On the 11th January, 1776, Congress ordered that persons refusing to receive the Continental bills in payment, or who should obstruct and discourage the circulation thereof, should, on conviction, be deemed, pub ished and treated as an enemy of the country, to hear from all quarters of the wonderful healthful- and be precluded from all trade or intercourse with the inhabitants of the colonies.

On the 4th of March, a resolution was passed recommending a general disarning of disaffected persons throughout the colonies.
