Salaries are improving and there never are enough librarians to meet the demand." Professional librarians are classified as library workers who have an A. B. degree plus a degree in library science.

Miss Bishop then answered the question as to what the public has a right to expect of the public librarian. These expectations include review of the output of publishers and selection of books suitable to vicinity, ordering of books and materials, classification of material, answer questions, lend books, and promote use of the library for profit in business and for personal study and enrichment.

Miss Bishop credited the WPA library projects with arousing public interest in the need for libraries. The federal government set aside money for people and supplies, but no money for books she recalled. In 1941 Miss Marie Beale, then secretary of the N. C. Library Commission "wheeled out" of the legislature the first \$100,000 biennial appropriation for state-wide library service. Each year since that time the grant has been increased. But in order to qualify for State Aid a county must have a library building, offer service to all, and employ a trained librarian.

In interesting contrast to then, which was 1941, and now the speaker cited these startling figures. In 1941, 28 counties had library service. Today, 96 counties have this service for their citizens. Then, there were 288,000 books; now there are 2,234,000 books. Then there were only 33 bookmobiles; now there are 96, with North Carolina possessing more bookmobiles than any other state in the union.

Fourteen years ago the total appropriations in the state for library service were in round numbers \$900,000. This year they are just the two million mark. These last figures include local appropriations by town, counties, Friends of the Library drives, and State aid.

Miss Bishop cited the interesting collections on special subjects being built up by North Carolina towns which are available on an inter-loan program for various localities. For example Raleigh is building a fine collection of art books. Mrs. Lamar Simmons Heads Lillington Club

Election of new officers and a talk on North Carolina libraries featured the meeting of the Lillington Woman's Club held Friday afternoon at the Community Center.

Mrs. Lamar Simmons, president, whose term will not begin until after the State Federation meeting in the Spring, will succeed Mrs. Joel Layton, Jr., who will continue as vice president. Other new officers elected at the same time were Mrs. W. B. Hunter, secretary; and Mrs. J. J. Lanier, treasurer. They succeed Mrs. F. M. Puryear and Mrs. Leon Kelly in the two positions.

New officers were recommended by a nominating committee composed of Mrs. J. G. Gourley, chairman, Mrs. W. B. Hunter and Mrs. Leon Kelly.

Miss Evelyn Bishop of Smithfield, Johnston County librarian and consultant to the Harnett County library, was the guest speaker. She was introduced by Mrs. S. R. McKay, Harnett librarian who also had arranged an interesting display of new books and had the bookmobile open for inspection at the door.

The program entitled, "Know Your Library" was one of a series on North Carolina which the club is emphasizing this year. Mrs. Nell McLaughlin and Mrs. W. B. Hunter, chairman of literature and education, arranged the program.

Miss Bishop, who is a native of Ohio has been living in North Carolina since 1950. "I selected North Carolina out of all the other 48 states as a place to live, and I think I made the correct choice," she said. She is a graduate of Hiram College and holds a degree in library science from Western Reserve College in Cleveland. She has been director of the Johnston County library since 1950.

Progress in library service since 1941 in North Carolina has been nothing less than sensational," Miss Bishop said. But in order to fit North Carolina into the picture, she gave some over-all data on libraries in the U.S.A. The figures do not include school or university libraries or the Library of Congress.

Last year the United States had 7,500 public libraries, one hundred million borrowers, and 125 million books. These libraries employed 40,000 persons, but only 15,000 were professional librarians. "So, if you know any talented young people who like books or written materials," Miss Bishop said, "direct them to the library field. Salaries are improving and there never are enough librarians to meet the demand." Professional librarians are classified as library workers who have an A. B. degree plus a degree in library science.

Miss Bishop then answered the question as to what the public has a right to expect of the public librarian. These expectations include review of the output of publishers and selection of books suitable to vicinity, ordering of books and materials, classification of material, answer questions, lend books, and promote use of the library for profit in business and for personal study and enrichment.

Miss Bishop credited the WPA library projects with arousing public interest in the need for libraries. The federal government set aside money for people and supplies, but no money for books she recalled. In 1941 Miss Marie Beale, then secretary of the N. C. Library Commission "wheeled out" of the legislature the first \$100,000 biennial appropriation for state-wide library service. Each year since that time the grant has been increased. But in order to qualify for State Aid a county must have a library building, offer service to all, and employ a trained librarian.

In interesting contrast to then, which was 1941, and now the speaker cited these startling figures. In 1941, 28 counties had library service. Today, 96 counties have this service for their citizens. Then, there were 288,000 books; now there are 2,234,000 books. Then there were only 33 bookmobiles; now there are 96, with North Carolina possessing more bookmobiles than any other state in the union.

Fourteen years ago the total appropriations in the state for library service were in round numbers \$900,000. This year they are just the two million mark. These last figures include local appropriations by town, counties, Friends of the Library drives, and State aid.

Miss Bishop cited the interesting collections on special subjects being built up by North Carolina towns which are available on an inter-loan program for various localities. For example Raleigh is building a fine collection of art books. Greensboro has one on business and industry; Durham on family and home life; Salisbury on gardening, Fayetteville on human relations, Raleigh Negro library on books by and for the Negro; and Charlotte on tax files.

Miss Bishop paid tribute to the long service of Miss Beal on the library commission and Miss Carrie Broughton, librarian for the State Library in Raleigh. These institutions will be united in one new library department which will be headed by Mrs. Miles Hughey.

"In spite of the fact that North Carolina is tops among the South and among the first ten among all states in offering library service to the public, much remains to be done.

We need more support, more interest, and more young people in library service," said Miss Bishop. "We have done so much, with so little only fifty cents per capita."

Mrs. McKay said that unfortunately there was no definite announcement to be made at this time about the new county library. The lot has been bought and \$15,000 set aside but so far work as yet to be started. However, commissioners have approved the start of the work at an early date.

At the social hour, coffee, fudge cake squares, cookies and assorted sandwiches were served. The refreshment table was covered with green cloth and centered with green candles in silver candleabra.
