RD DENOUNCES BROWNELL, WARR Sen. Kefauver **Takes Stand** 

# **Against South**

WASHINGTON (UP) Sen. Harry F. Byrd (D-Va.) bitterly denounced Chief Justice Earl Warren and Attorney Gen. Herbert Brownell today in a Senate speech attacking the administration's civil rights bill.

Byrd likened Warren to Thaddeus Stevens, the South's chief foe during the Reconstruction era. And he said Brownell would be "20th Century American Caesar" under the bill.

Byrd's assault came as the Senate prepared to vote some time between 4:15 and 6:15 p.m. on the motion to take up the measure. The motion was sure to be approved by a sizable majority despite southern opposition.

Byrd said President Lisenhower, the House sponsor of the bill and the chairman of the House committee which handled it did not know what it contained.

"Of course, I have no documentary proof," Byrd said, "and I suspect by design there is none, but speaking only for myself, I strongly suspect that the modern Thaddeus Stevens now cloaked in the robe of the chief justice of the Supreme Court, has a thorough and complete knowledge of what could and would be done under the bill."


